Our rescue and adoption program provides a safety net for cats who would be euthanized at the shelter because they seem unadoptable there, and because there is no other local rescue group who would help these cats. During 2022, we maintained a program of approximately 50 foster cats at any given time, including seniors with medical needs, cats recovering from surgery and cats who were so stressed or shut down at the shelter as to be unadoptable there.

At our adoption center - the first of its kind in the USA - we house up to 50 adoptable cats in a cage-free environment.

Through our education and public outreach programs, we inspire other animal welfare organizations to embrace and adapt our programs for their own communities. Through our partnership with Maddie's Fund, we have trained animal welfare professionals from more than 60 cities on assessing, rescuing, and adopting hard-to-place cats that are at high risk for euthanasia throughout many parts of the country.

In 2022 we launched an online self-paced version of our training program. It has been one of the most popular courses on Maddie's University in 2022. In addition, we support our local community with information and resources about cat care, welfare, rehoming, trap-neuter-return, and other animal welfare issues.

Through our pet retention programs, we enable adopters of Cat Town cats to keep their adopted pets in their homes. For all adopters, we offer extensive counseling and behavioral support via our case management program for a wide variety of behavior issues. Our In-It-For-Life hospice program provides financial assistance to adopters of cats that have untreatable, terminal medical conditions, ensuring that the cost of veterinary care does not become a barrier to finding great homes for these cats in their final months or years.

Volunteer roles include fosters, interacting with visitors to the adoption center, socializing fearful cats and helping with marketing, fundraising, outreach and transportation. Cat Town is lucky to have such a strong community of support and we could not do this work without our wonderful volunteers.

Our rescue and adoption program provides a safety net for cats who would be euthanized at the shelter because they seem unadoptable there, and because there is no other local rescue group who would help these cats. During 2021, we maintained a program of approximately 50 foster cats at any given time, including seniors with medical needs, cats recovering from surgery and cats who were so stressed or shut down at the shelter as to be unadoptable there.

At our adoption center - the first of its kind in the USA - we house up to 50 cats in a completely cage-free environment. We focus on socializing older kittens through our Forgotten Kitten Project. These are hard-to-place kittens who come into our municipal shelter partner at three months or older, after the ideal window for socializing them has closed. Because socializing them is so challenging, they are overlooked by other groups and at high risk for euthanasia. In addition, this center provides special

housing for cats who are under socialized, older and/or have medical needs,
